Spanish Proficiency Test Now Available

Bilingual provider: A health care provider with proficiency in more than one language, enabling him or her to provide services directly to patients with language needs in their preferred language.

Lexington Medical Center Interpreter Services has developed a Spanish proficiency test to determine an employee's ability to effectively carry out the duties of their job in Spanish without the assistance of an interpreter. This test is required by for employees to speak Spanish on-the-job without the use of an interpreter.

There are two versions of the Spanish proficiency test. The medical test is for physicians, nurse practitioners and nurses. The general test is for staff not involved in clinical care such as registration and billing representatives. Staff members who pass the test will receive a validation number and identification as a bilingual staff member on their badge. It is important to note that this test evaluates Spanish proficiency, not interpretive ability. Therefore, anyone who successfully passes the exam will be permitted to communicate with patients directly in Spanish, not interpret for LEP patients and other non-Spanish speaking LMC staff.

Sparkling Strawberry Lemonade
